Motion made by Susan S to approve the November 25, 2025 MSEES meeting agenda.
Seconded by Shalene C. Carried.

Motion made by Shalene C to approve the MSEES meeting minutes from September 23, 2025.
Seconded by Erica M Carried.

1. **Treasurer Update** (Adam P/ Kristine C)

A. There is \$32,438.21 the cash account (\$17,381.43 unreserved) and \$145,211.54 in casino fund (\$90,778.22 unreserved).

2. **Chair Update**

A. Kristine C presented some Fundraising Brainstorms. Presenting Milk Jar Candles, this is online and low effort; Simple Simon Pies, Beef Jerky and Pie Junkie (vouchers or product). Tabling these ideas for now with potential for beef jerky around Father's Day and Milk Candles around Mother's Day. Adam P also brought forward Krispy Kreme.

B. 12 Days of Treats email sign up- December 8-15. Sign up 2 daily volunteers to bring in treats (homemade or purchased) to over 50 staff members with sweet/ savoury alternating to celebrate them the last two weeks before winter break.

C. Adopt A Family tabling this conversation for now.

3. **Coordinator/Committee Updates**

A. Staff Appreciation update (Danny Y): Staff enjoyed pastries and sweets for teacher appreciation when they returned, complete with "you're awesome" stickers. He will try to fit in one more appreciation event later this week.

B. Fun Lunch update: Amanda O has reported to Kristine C that fun lunch sales are down, but volunteers are fantastic.

C. Casino Update- there is no update today.

4. **Funding Requests**

- A. **Teacher Holiday Meal.** Charlene K requested up to \$800 cash and 15 volunteers for Teacher Holiday Meal over a lunch hour. Parent volunteers are needed to supervise students.

Motion made by Kristine C to use up to \$800 from the cash account to support Charlene K in hosting a Holiday Teacher Meal in December. Seconded by Erica M. 9 voted in favour, 1 abstain. Carried.

- B. **Leadership Student Birthdays.**

Shalene C motioned to use up to \$500 from the cash account for student birthday gifts. Erica M seconded. All present (10) voted in favour. Carried.

- C. **Parent Teacher Conference Meal.**

Erica M motioned to use up to \$800 from the cash account for meals for teachers working during Parent Teacher conferences. Seconded by Shalene C. 9 in favour 1 abstain. Carried.

D. **Caring for the Community.** Charlene K requested a reboot to this balance. This request will remain on hold for now.

E. **Adopt A Family Leadership Carnival.** Charlene K requested \$600 to rent two machines for the Carnival and \$600 for paper rolls.

Shalene C motioned to use \$600 towards carnival games from the cash account. Erica M seconded. 9 in favour 1 abstain. Carried.

F. **Jr. High Dance February 2026.** \$800 requested from the cash account to host a DJ and decorate with a concession, pizza pops, and treats during school hours. Halloween dance funds to go back to this fund (less candy purchased).

Shalene C motioned to approve up to \$800 from the cash account to be used for a Jr High 2026 dance, Tiana L seconded. 9 in favour. 1 abstain. Carried.

Danny Y and Susan S left

G. Pulse Dance Studio Residency. Jen Purslow requested \$3300 plus GST for a gym 2-3 day dance residency January 6-8 with Pulse Dance Studio for all grades.

Kristine C proposed to support up to \$3500 from the casino account to support Pulse Dance residency January 2026. Shalene C made a motion to approve this request. Erica M seconded. 7 in favour, 1 abstain. Carried.

H. Drama Production. Ms. Zima requested \$1600 for Spring Drama production, with profits from ticket sales to return back to council budget.

Kristine C motioned to approve up to \$2000 from the casino account to support Drama 2026 production, with the understanding that ticket sales be used to reimburse. Jamie seconded. All present (7) in favour with 1 abstain. Carried.
