Motion made by Erica M to approve the September 24, 2024 MSEES meeting agenda. Seconded by Danny Y. Carried.

Motion made by Shelly C to approve the MSEES meeting minutes from May 28, 2024. Seconded by Callie S. Carried.

1. AGM

Kristine C-G noted to let the motion stand from the previous MidSun School Council meeting for 2024-2025 MSEES executive positions (elected) and volunteer/appointed positions.

- 2. Treasurer Update (Erin L not in attendance)
 - A. Kristine C-G briefly discussed the difference between the two accounts, how the funds are used and updated the group on a few remaining 2023-2024 reserved funds.
 - B. Cash Account Balance: \$27,364.01 (\$303.51 reserved) and the Casino Account Balance: \$74,409.32 (\$7000 reserved)
 - C. Kristine C-G noted that \$800 was set aside by request of the past principal for the 2023 report card lunch for staff but no receipt was submitted or reimbursed. Jenn G to follow up.
 - D. Kristine C-G also inquired about \$4000 of held funds for the book replenishment in the learning commons. Jenn G to follow up.
 - E. Kristine C-G also reminded the group about funds held for grow lights that were unused.

Motion made by Danny Y to return the grow light funds for \$700 to unreserved funds. Seconded by Jeanne F. All present (17) voted in favour. Carried.

3. Chair Update

- B. Kristine C-G asked for volunteers to work the council table at Meet the Teacher night September 26 from 6-7:30pm. Mona S and Jen D volunteered.
- C. Kristine C-G thanked the 2023-2024 MSEES council members.

- Motion made by Kristine C-G to use \$800 from General Account be used for a teacher meal during meet the teacher night. Seconded by Jen D. All present (17) voted in favour. Carried.
- B. Kristine C-G asked for \$1000 (from General Account) for staff appreciation dropoffs throughout the year.
- Motion made by Kristine C-G to reserve up to \$1000 of funds from the general for staff appreciation drop-offs. Seconded by Sherry C. All present (17) voted in favour. Carried.

6. New Business / Open Table

- A. Jenn G shared a funding request form and discussed the intention to invite an elder to the school for hoop dancing and to share information with the students about indigenous history, diversity and inclusion.
- Motion made by Kristine C-G to reserve up to \$4000 of funds from the Casino Account for the truth and reconciliation presentation and if not possible from the Casino

Account, to be used from the General Account as noted above. Seconded by Sherry C. All present (17) voted in favour. Carried.

Motion made by Kristine C-G to reserve up to \$600 of funds from the General Account to purchase gifts for the elders presenting in the school as noted above. Seconded by Tiana L. All present (17) voted in favour. Carried.
